Exhibitor/ Seller Guidelines

1. Pre-Event Application and Requirements

Here's everything you need to know when planning to exhibit Hunting Guns at ADIHEX:



SUBMISSION DEADLINE

your lists must be submitted no later than **15 July 2019**



PRE-EVENT REQUIREMENTS

Submit a copy of the following:

- Your Trade License
- The weapon list in excel format provided by the organisers

PERMITS & LICENSES

Any permits/licenses required from your country of origin will have to be requested from your end and is not the organisers' responsibility. However, a Letter of Intention may be issued upon request.



NOTICE OF APPROVAL

Once your list is approved by the Abu Dhabi Police, a copy of the NOC (No Objection Letter) will be sent to you along with the list.



OTHER USEFUL INFORMATION

Request for additional items will NOT be accepted after the NOC has been issued.

* Please ensure to follow the correct procedure in order to exhibit your weapons.

NOTE: Failure to follow these guidelines will result in the rejection of your application.

Exhibitor/ Seller Guidelines



Shipping, logistics and re-export:



Indicate Abu Dhabi as city of destination in United Arab Emirates



Ensure all shipments sent to the Abu Dhabi Police match the corresponding NOC (non Objection Certificate) issued to you.



Packaging of weapons should be according to the submitted item number and indicates serial number. Packing of DUMMY ammunition should be secured.



No dummy cartridge or ammunition should be given away OR left after the exhibition.

All dummies must be handed over to the Abu Dhabi Police.



All unsold weapons should be sent back to the country of origin.

Your Products at ADIHEX



Display Of Weapons:

Weapons shall enter the state via one of Abu Dhabi's ports (land, sea and air) The display of exhibits is strictly in accordance with exhibition rules and regulations (see terms & conditions on your participation contract). No live ammunition or explosives will be exhibited on the stands except models, dummy, inert or live cutaways.

It is a requirement from the "Abu Dhabi Weapons & Explosive Department" that there should be no loose weapons on the stands or counters and all weapons **MUST BE PERMANENTLY SECURED.**

Each weapon should have a trigger lock – as per the visual – **FAILURE TO COMPLY WILL RESULT IN INABILITY OF THE COMPANY TO DISPLAY THE WEAPON**



Weapon for the purpose of the exhibition includes:

- Rifles
- Pistols
- Revolvers
- Heritage Daggers ONLY
- Hunting Knives ONLY
- Wooden & plastic archery items ONLY
- Airguns, authorized bit not more 8 joules (if over, the stand will be cancelled)



Prohibited Weapon includes:

- All weapons/products manufactured in Israel
- Knives & white arms used in unusual civilian purposes
- Swords and daggers (excluding heritage)
- Fencing, spears and arrows
- Pickaxe & axes used in unusual civilian purposes
- Punching accessories made for killing or abusing
- Sticks with harpoon or heavily metals made for combat purposes
- Spear weapons
- Machete Combat
- Pin or stick or roller chains, which ends with thorns
- Chains linked to white arms

DISPLAYING of SILENCERS & LASERBEAMS:

If you have received an exceptional approval for silencers and laser beams, please note that these to be displayed in an enclosed area such as a storage area, for private viewing only (VIP's & Royal Family)

It has also been requested that each weaponry & co-exhibitor appoints only 1 or 2 stand representatives to deal with the Abu Dhabi Weapons & Explosive Department, to avoid congestion in the storage area.

Only specialised staff will be allowed to present and sell weaponry to visitors – it is not acceptable to allow 'non-specialist' persons, including family members to present, discuss or sell weaponry products from a stand. "Abu Dhabi Weapons & Explosive Department" will act accordingly wherever this is found to be happening from an exhibitors stand, one of the consequences being fined.

*** Please make sure that the weapon is not sold for more than one person.**

Weapons can only be sold to UAE Nationals only.



Sale Of Weapons & Ammunition:

The sale of weapons and ammunition (DUMMY ammunition) during ADIHEX is governed by instructions and procedure that is clearly presented to the concerned exhibitors for strict adherence.

The only permitted weapons to sell during the show are the list approved by the Police.

An invoice book will be handed over to the weaponry exhibitor's onsite for the selling/invoicing process.

Following your selling transaction the buyer will have to follow the below described procedures for buying weapons in the UAE

Once the buyer has completed licensing, exhibitors must report the transaction to the "Abu Dhabi Weapons & Explosive Department" for registration and documentation. We highly encourage exhibitors to keep sold items on display till the end of the show – to allow other visitors to experience the product.

Exhibitors selling weaponry must ensure to stop selling weapons by 20:00hrs daily.

It is strictly prohibited to sell to any one, please rely on the Ministry of Interior permits.

Other important information in regards to the exhibition stand:

Stand setup - EXHIBITORS:

- The placement of your weapons can only commence once the stand has been completed and cleared from contractors.
- On the last day of build, Exhibitors MUST vacate the halls no later than 20:00hrs. Be advised that Abu Dhabi Police will vacate all halls for a security sweep. Please ensure that your stand is fully completed by then to avoid any fines.
- Laser, electric sticks and electric self-defense items are strictly prohibited by Abu Dhabi Police.

BUILD UP for CONTRACTORS:

On the day before the event (last day of build), **Stand build must be completed by 10:00hrs and contractors MUST vacate the halls at 12:00hrs. NO extra time will be given, please ensure that your stand contractor is aware of it as it will result a considerable fine**
